These flights will be highlighted in a coupon booklet, where vendors can set a regular price and offer a reduced price through the booklet (created below).

- Applications are reviewed on a first-come-first-served basis, giving previous Vendors preference.
- MN Operator Certificate of Compliance (ST-19) is required with the application.
- Certificate of Liability Insurance naming the Hinckley Chamber of Commerce and the City of Hinckley as also insured is required with the application. Minimum Limits \$300,000.
- The booth size is approximately 10' X 10' or whatever size is required by a food truck.
- NOTE: This is an outdoor event
- Return forms by July 1, 2024.
